Cellar 2 Seller is hosting a one day knowledge exchange, aimed at brand owners, both experienced and new to keg dispense. The day will share knowledge and information, aiming to develop and strengthen the cellar service technician network and educate new to keg brand owners of their responsibilities. Alongside talks and presentations, dispense sector manufacturers, suppliers and installers will showcase their products and services via a tabletop exhibition.

The day will benefit from 1 day/6 hours' worth of CPD points and a CPD Certificate of Attendance will be given to all attendees.

Sessions include:

- A review of the recently published BBPA 6th Edition of the Pressure Code of Practice.
- A session aimed at new to keg brand owners, explaining what they need to know in order to ensure their beer is right for the outlet and the practicalities of how to access the primary dispense system.
- A Q & A session for new to industry technicians, providing an opportunity for newer cellar service technicians to ask questions, learn the common faults, develop a network of peers for future consultation.
